WAITING PERIODS

Dental PPO – The waiting period for Class IV, Orthodontia is 12 months for dependents up to age 26 and adults (for new plan members).

Class V, Implants is 12 months for new plan members.

Dental HMO – No Waiting Periods.

ELIGIBILITY

All members of the Protective Association, spouses and dependent children under the age of 26 are eligible.
